Business Tax Criteria

PA businesses that are C-Corps, S-Corps, LLCs, and Limited Partnerships are eligible to contribute up to \$750,000.

Receive a 75% tax credit for a one-year commitment

OR

Receive a 90% tax credit for a two-year commitment


Important dates for businesses

May 15:

Business applicants who have completed their two-year commitment and wish to reapply for another twoyear commitment.

Businesses who are in the middle of their two-year commitment.


